

Frequence Terms of Use

Acceptance

These terms of use are entered into between Frequence, Inc. ("Company," "we," or "us") and you, a user of our website or mobile applications ("you"). The following terms of use ("**Terms of Use**") govern your access to and use of www.frequence.com and mobile applications, including all associated content, functionality, and services on those properties (the "**Website**").

By using the Website, you accept and agree to be bound and abide by these Terms of Use and our Privacy Policy (located at <https://www.frequence.com/privacy-policy/>) which is incorporated into these Terms of Use. If you do not want to agree to these Terms of Use or the Privacy Policy, you must not access or use the Website.

This Website is offered and available to users who are 18 years of age or older. By using this Website, you represent and warrant that you are at least 18 years old. If you are not, do not access the Website.

Changes
